Mae angen y Gorchymyn i alluogi adnewyddu traciau.

Y ffordd arall yw o bwynt gogledd dwyreiniol y caead, teithio mewn cyfeiriad gogledd dwyreiniol ar hyd y B4545 Ffordd yr Orsaf, Y Fali i'r groesffordd gyda'r A5 ger y Valley Hotel. Troi i'r chwith i fynd ar yr A5 a chario 'mlaen mewn cyfeiriad gogledd gorllewinol i'r gyffordd gyda Lôn Spencer. Troi i'r chwith i fynd ar Lôn Spencer a pharhau mewn cyfeiriad de gorllewinol i'r gyffordd gyda'r B4545 Ffordd yr Orsaf. Bydd y gwrthwyneb yn berthnasol i draffig sy'n teithio o'r cyfeiriad arall.

Daw'r Gorchymyn i rym ar 17eg Mai 2024 a bydd yn parhau mewn grym am gyfnod na fydd yn fwy na 6 wythnos neu hyd nes y cwblheir y gwaith y bwriedir ei wneud ar y ffordd, pa un bynnag fyddo gyntaf. Ar hyn o bryd, rhagwelir y bydd y gwaith yn digwydd yn barhaus rhwng 11:00yh ar 17eg Mai 2024 a 6:00yb ar 20fed Mai 2024 ac yna dros nos rhwng 10:00yh ar 25ain Mai 2024 ac 8:00yb ar 26ain Mai 2024, rhwng 10:00yh ar 1af Mehefin 2024 ac 8:00yb ar 2il Mehefin 2024 a rhwng 10:00yh ar 8fed Mehefin 2024 ac 8:00yb ar 9fed Mehefin 2024.


NOTICE IS HEREBY GIVEN that Cyngor Sir Ynys Môn/Isle of Anglesey County Council intend not less than seven days from the date hereof to make an Order, the effect of which will temporarily prohibit all vehicles, except for emergency vehicles, from travelling in either direction across Valley Level Crossing.

The Order is necessary to enable track renewal.

The alternative route will be from the north eastern point of the closure, travel in a north easterly direction along the B4545 Station Road Valley to the crossroads with the A5 by the Valley Hotel. Turn left onto the A5 and proceed in a north westerly direction to the junction with Spencer Road. Turn left onto Spencer Road and proceed in a south westerly direction to the junction with the B4545 Station Road, and vice versa for traffic travelling in the other direction.

The Order comes into effect on 17th May 2024 and will continue in force for a period not exceeding 6 weeks or until the work which it is proposed to carry out on the road is completed, whichever is the earlier. At this stage it is anticipated that the works will take place continuously between 11:00pm on 17th May 2024 and 6:00am on 20th May 2024 and then overnight between 10:00pm on 25th May 2024 and 8:00am on 26th May 2024, between 10:00pm on 1st June 2024 and 8:00am on 2nd June 2024 and between 10:00pm on 8th June 2024 and 8:00am on 9th June 2024.
