Awgrymodd sefydlu 'Siediau Ieuencid' a digwyddiadau ymgysylltu â'r gymuned i geisio dod ag ymddygiad gwrthgymdeithasol i lawr. Cytunodd Mr Dunbobbin i gadw mewn cysylltiad â'r Cyngor.</p> <p>Gadawodd Mr Dunbobbin a Mr Hughes y cyfarfod.</p> | <p><b>Mr Andy Dunbobbin, North Wales Police and Crime Commissioner (PCC) and Dyfed Hughes (94283) Communications &amp; Engagement Officer, Office of the Police and Crime Commissioner</b><br/>The clerk presented an overview of the vandalism, antisocial behaviour and parking issues endured in and around the village. Members also highlighted issues with 'joy riding' and the traffic bottle necks and hazardous conditions caused with inconsiderate parking on Station Road. Actions already taken were discussed. The deployment of traffic enforcement officer by the County Council was acknowledged, however members felt that officers standing on duty at the zebra crossing was probably ineffective.</p> <p>Members requested increased police presence in the village and active enforcement. Education plus youth and community engagement was also considered key to combating some of the village problems.</p> <p>Mr Dunbobbin advised that some PACT funding, from proceeds of crime, was available to help replace and repair damage caused through vandalism etc. He suggested establishing 'Youth Sheds' and community engagement events to try and bring antisocial behaviour down. Members are dismayed over the lack of PCSO engagement at Council meetings despite numerous invitations issued. Mr Dunbobbin advised that he would pass on the Council's request to improve the relationship between the Council and local police and that all the Councils observations would feed into the strategic direction for the police in North Wales.</p> <p>A North Wales Police and Crime Commissioners Public Consultation has been launched and Mr Dunbobbin encouraged members to promote and submit surveys to feed into this work. Mr Dunbobbin agreed to keep in contact with the Council..</p> <p>Mr Dunbobbin and Mr Hughes left the meeting.</p> |
