The agenda was paused to allow feedback from NWP.</p> <p>It was confirmed that the following officers now cover the Holyhead operational area, i.e. PCSO 3689 Kelly Williams (full time) and PCSO 2943 Kelly Tatlock (part time).</p> <p>The vandalism in Parc Mwd was discussed. The Officer advised that two young teenage boys had been remanded in custody and have now been placed out of the area. She hoped that incidents would now be reduced. She also emphasised the need to report all incidents to the police either via calling 101 or online through the NWP website.</p> <p>Inconsiderate parking in the village was discussed especially near the new zebra crossing. Members gave examples of large vehicles encroaching on the crossing and times of incidents.
