Cynyddir y gyllideb ddiwygiedig ar gyfer y flwyddyn i £63,921.02 i gynnwys prosiectau Cwrt Pêl-fasged, Mannau Gwyrdd a Rampiau Cyflymder. Derbyniwyd yr holl arian grant. Mae'r gwariant ar 30/9/24 yn £18,681.70.	Finance 2024/25 The clerk confirmed that the budget for the period is on track. She confirmed the set budget was £14,621.02. The revised budget for the year is increased to £63,921.02 to include Basketball Court, Green Spaces and Speed Ramp projects. All grant money has been received. The expenditure at 30/9/24 stands at £18,681.70.

Bwriedir symud ymlaen yn y 2 fis nesaf.</p>	<p>Project Updates</p> <p><u>Basketball Court</u> – The Clerk confirmed that Lagan Aviation Infrastructure Ltd had agreed to provide the ground works for the Court. This offer in turn has reduced the cost of the Court. Discussions had taken place with suppliers and the lowest quote produced by G J Jones Ltd is now revised and reduced to £38,150. Grant funding of £38k has been received. The work is scheduled to start in the next 2 months.</p> <p>The willow tree has been cut back, however members agreed that it would be better to remove existing tree and plant 3 new native trees closer to the rear wall and in-line with the planning consent.</p> <p>Recommendation 2: To accept the offer from Lagan Aviation and the revised quotation from G L Jones Ltd of £38,150</p> <p>Recommendation 3: To approve removal of willow tree at rear of the proposed basketball court and replace with 3 native trees.</p> <p><u>Triangle Upgrade</u> - The Clerk confirmed that the objectives of the Green Spaces grant were now complete. The evaluation report to be produced by November. Work can now continue to tidy up existing shrubs.</p> <p><u>Speed Bumps</u> – The clerk awaits further quotations. Mr N Tuck reported that he had taken One Voice Wales advice on the matter due to recurring problems over the last 3 years. However, the committee was reassured, and the club's representatives agreed to resolve the situation as soon as possible. Some clearing work had already taken place. Storage will be improved once containers are in place. Items in the roof space to be removed immediately. Cllr I Jones agreed to arrange to dispose of the items.</p> <p>The Clerk to explore the standards required with food hygiene and sale of food etc.</p> <p>The Committee understood that the Football club currently have under 7, 11 and 12 junior players and a Senior Team. It was confirmed the Pavilion may be opened on Mon, Weds, Sat and Sundays i.e. main days for training and matches.</p> <p>The Committee was advised that portable lights had been purchased for training during winter evenings. Representatives were advised of the need to protect wild life. The Clerk to forward guidance given by Planning Dept to the secretary. External electric socket would be useful for charging these lights prior to training.</p> <p>Recommendation 4. To approve installation of external electricity point in the cage outside the pavilion.</p> <p>Cllr Tuck advised that the Council would like to formally present a Certificate or Shield each year to a player. The Council will agree criteria in due course.</p>
