The revised cost to deliver the basketball court is £38,150 with grants to the value of £38,000 secured. However, she noted that there is a risk that the Bro Llynnoedd Grant of £3,000 may be clawed back as the work has not been completed by 30/11/24. This is beyond the council's control. Site clearance has started and all goods have been ordered. The main installation is scheduled to start date on 20/1/2025.</p> <p>2. <u>Green Spaces Project</u> The clerk advised that the project to install an outdoor gym and repair the triangle perimeter is complete. The final cost was £12,825 of which £7,500 was grant funded. Volunteers will continue to maintain the space.</p> <p>3. <u>Speed Ramps</u> Money is set aside for the project and is intended to be completed before the end of the financial year.</p> <p>4. <u>Stone Bus Shelter & Bike Rack</u> The clerk confirmed that a regeneration grant of £10,000 has been approved to replace the bus stop on Station Road and install a bike rack in the public car park. Quotations have been received. The installation is scheduled for 18-19/12/24.</p> <p>The Committee compared quotations for 2 styles of bike racks. The linked rack was preferred by the committee. . The clerk will seek the necessary approvals before any orders are placed. All works to be completed before 31/12/24.</p>

This threshold will be increased by the consumer price index (CPI) after 6 April 2028.
